## BIG BUNSBY MARINE PROVINCIAL PARK Purpose Statement and Zoning Plan

### Primary Role

The **primary** role of Big Bunsby Marine Park is to provide a remote marine recreation experience in the Kyuquot Sound area off the west coast of Vancouver Island. Big Bunsby Marine Park contains some of the best all-weather anchorages in Checleset Bay and recreation opportunities include sea kayaking, wilderness camping, fishing, swimming, and nature observation. As yet, there are no facilities and access is by boat only.

The park was added to the protected areas system to focus recreation away from the adjacent Checleset Bay Ecological Reserve and its extensive area of marine shoreline, reefs, islets, and kelp beds that provide habitat for British Columbia's recovering sea otter population.

### Secondary Role

The **secondary** role is to protect First Nation cultural values. The park protects significant First Nations values that offer glimpses to the past and demonstrate their tie to the land.

Impact of recreational development on natural and cultural values	<ul style="list-style-type: none"> <li>➤ Formalize camping area and facilities to concentrate impacts to one area.</li> <li>➤ Provide visitors with information on no trace camping.</li> </ul>
Lack of potable water for campers	<ul style="list-style-type: none"> <li>➤ Provide information to potential visitors on water limitations before they leave. Ensure that information is on the website.</li> </ul>
Impact of surrounding land uses on natural values	<ul style="list-style-type: none"> <li>➤ Liaison with DFO to monitor impact of commercial invertebrate harvesting.</li> <li>➤ Work with Ministry of Forests to monitor for the illegal activity of log salvaging.</li> </ul>
Strained First Nations relations	<ul style="list-style-type: none"> <li>➤ Develop good working relationships with First Nations to develop an understanding and appreciation of protected area status and park values.</li> </ul>

### Zoning

**Natural Environment Zone** - covers the entire park (658 hectares). The objective of this zone is to protect scenic values and to provide recreation opportunities in a largely undisturbed natural environment.
