

Q1 Have you ever visited Liard River Hot Springs Provincial Park? If so, how often do you visit?



Q2 What time of year do you prefer to visit the park?



Q3 What type of facilities do you use when visiting the park?



Q4 What type of activities do you like to do at Liard River Hot Springs Park or in the general area? Choose all that apply.





Q5 Have you ever camped in the overflow camping area across the highway from the campground because the campground was full?






