Upper Violet Creek Provincial Park Purpose Statement and Zoning Plan

Introduction

Upper Violet Park is located 12 kilometres southeast of Salmon Arm on the southeastern edge of the Larch Hills. The 124 hectare park captures the major sections of Upper Violet Creek that flow into Mara Meadows Ecological Reserve. Park boundaries generally run 50 metres parallel on either side of the main stream course for about five and half kilometres, and along either side of two short tributaries. Boggy wetlands at the top end of the two tributaries are included in the park boundaries. The continuity of park boundaries along the stream is interrupted by a 660 metre section of private land near the lower end. The legal park boundary definitions also exclude the rights-of-way of three forest development roads that cross through the park.

Primary Role

The **primary role** of Upper Violet Park is to protect one of two major sources of water entering Mara Meadows Ecological Reserve. Conservation of the unique wetland habitats and rare plants of Mara Meadow is dependent upon the maintenance of the existing quantity and quality of water flowing in from Upper Violet Creek. The pending designation of Mara Meadows Park (recommended in the Okanagan-Shuswap Land and Resource Management Plan) around the north and east sides of the ecological reserve will provide similar protection along the other main drainage leading into the meadows. As further measure of protection, water rights to the creek are reserved in favour of the Ministry by Order-in-Council.

The riparian habitats along the creek and around the boggy wetlands are covered in mixed forest of western red cedar, hemlock, paper birch and cottonwood trees with shrubby understory of willows and red osier dogwood. These habitats are very stable and the location and condition of the pre-existing road crossings ensure little risk of damage from erosion or runoff. Forest developments on adjacent woodlot and crown lands may, however, have potential to impact the watershed.

A **secondary role** of Upper Violet Creek Park is to provide for continued recreational use of the cross country ski trails that cross through the area. These trails pre-exist the park and are well maintained by the local cross country ski club. The trails and the use of the trails pose little threat to park values.

- Monitor water flow and water chemistry


